ZUMBRO LUTHERAN CHURCH ANNUAL CONGREGATIONAL MEETING FEBRUARY 5, 2023 / ZOOM

CALL TO ORDER -Joe Ahrens

President Joe Ahrens called the meeting to order and reviewed the annual meeting agenda.

DEVOTIONS—Pastor Shelley Cunningham

ESTABLISHMENT OF A QUORUM—Jane Callahan

Jane shared that we have at least 50 in person attendees, establishing a quorum according to the By Laws of ZLC.

APPROVAL OF THE FEBRUARY 6, 2022 ANNUAL MEETING MINUTES

Motion and second from the floor. No discussion. Congregation voted. Motion was unanimously approved.

APPROVAL OF THE DECEMBER 2022 SPECIAL CONGREGATIONAL MEETING MINUTES

Motion and second from the floor. No discussion. Congregation voted. Motion was unanimously approved.

TREASURER'S REPORT-Council Treasurer Jim Peterson

Net income

Actual giving (\$1.343M) was 2% higher than budget (\$1.316M) and 4% higher than 2021 (\$1.29M).

Net income was negative \$76,178 derived from actual income (\$1.756M) vs. actual expense (\$1.822).

Net income included non-sustainable sources chiefly: unexpected gift of \$48.5K, \$147,000 IRS rebate, and \$113K from capital campaign.

Expenses

ZLC met its budgeted benevolence (\$80K) to ELCA Southeast MN Synod. Largest expenses included personnel (64%), and mortgage (16%) of budget. Capital campaign receipts total \$2.8M to date. Expenses to date include \$5.6M with \$50K remaining in estimated expenditures for organ and other misc. costs.

Discussion:

Question from the floor regarding clarification of the nature of the \$48.5K large gift. Jim shared that he did not recall the specifics.

PRESENTATION OF THE 2023 BUDGET- Council Treasurer Jim Peterson

Proposed income

Budgeted income and expenses are \$1.8M for 2023 (balanced budget). Anticipated congregational giving is \$1.3M with \$214K in other giving. Council and finance team planned for \$288K in other income including additional \$186K from Capital Campaign (\$300K instead of \$113K original budgeted); \$50K in unused designated funds, and \$50K in saving or other revenue.

Proposed expenses

\$1.1M personnel (6.5% increase over 2022 including targeted staff salary increase).

\$561K in fixed cost (19.8% over 2022 budgeted, including increased mortgage payments and inflation).

Summary of recent income sources.

Recent unsustainable income sources included: PPP Loan forgiveness \$148K, IRS grant \$147K, large gift \$48.5K, and capital campaign contribution toward mortgage (\$113K).

VOTE ON THE 2023 BUDGET

President Joe Ahrens entertained motion to adopt the 2023 budget as proposed.

Rich Vetter motioned to approve. Second from the floor.

Discussion:

Zoom question: how does endowment affect our budget? **Answer**: Jim clarified that we have a \$1.1M endowment that provides \$40K toward operating expenses.

Question from the floor: question about membership in the past few years. **Answer**: Pastor Shelley shared that details can be found in the annual report but that membership has been relatively steady during that period.

Question from Dan van Dyke: How many years remain on the mortgage? **Answer**: Joe shared that we have 24 years left on our refinanced 25-year mortgage (\$3.4M at 4.25%).

Question from the floor: Has the use of the north lot been incorporated into thoughts about how to deal with budget deficit.

Answer: Jim shared that this has been very much at the center of conversation at council.

Answer: Joe shared that reforming the north lot committee in 2023 is a priority and that all options remain on the table.

No further discussion. Congregation voted. Motion was unanimously approved.

CHURCH COUNCIL PRESIDENT MARNE GADE

As anticipated, 2023 was a year of continued change and challenge for Zumbro Lutheran Church. More staffing changes. Continued financial challenges.

Midst that change and challenge, the Zumbro Lutheran Church Council focused its energy on several key areas within their responsibilities, including:

- Lead the congregation in stating its mission, do long-range planning, set goals and priorities and evaluate its activities in light of its mission and goals.
- Oversight of all paid staff positions.
- Maintain and protect the financial and property matters of the congregation.
- Emphasize support of the synod and churchwide organization of the ELCA as well as cooperation with other congregations.

In keeping with those responsibilities, the church council adopted the following priorities:

- 1. Grow and expand the reach of Zumbro Lutheran
 - Develop a membership recruitment and growth plan
 - Sustain and grow a strong children/youth/family ministry
 - Ensure that current, new and potential members feel welcomed, engaged and inspired to participate in the life of the congregation
 - Sustain support of Zumbro's missional outreach in the community and beyond
- 2. Refine and implement a sustainable long-term financial plan
- 3. Support and strengthen staff and congregational leadership
- 4. Embrace Zumbro's values, culture and traditions while building new ways to thrive amidst change

The council and pastors have worked hard and made considerable progress in 2023.

As Zumbro Lutheran replaced roles vacated by Jen Gruendler, Kristy and Bob Giere, the council partnered with pastoral staff to define the evolved job descriptions and provided oversight of the hiring process, and provided input and approval of their replacement roles. As Matt Gender and Pastor Anna Ferro joined the staff and staff members Janette Davis, Sarah Lichty and Tracy Schar transitioned into new roles, the council ensured Zumbro's personnel expenses stayed within approved budget. We appreciate all of the staff's dedication and flexibility to support the congregation, as well as the Personnel Team for their assistance with these changes.

As the church council and pastors closely monitored financial performance, the council and pastors formulated and successfully implemented a plan to ensure Zumbro Lutheran met its financial performance targets. A skilled Stewardship Team, advised by a consulting group, led this year's pledge campaign, *Planting Seeds*, urging all Zumbro Lutheran Church members to consider pledging in 2024, and members who routinely pledge to consider increasing their pledge. The Mission & Outreach Team and Gifts & Memorials Team continued to lead efforts to support Zumbro Lutheran's mission work, as well as support our mission partners and the ECLA.

The council approved a recommendation for restructuring space rental contracts that offer discounts to renters who fit our mission while charging market rates to others based on market rate data provided by the administrative staff. This action sets the stage for increased revenue as rental contracts come due for renegotiation.

To sustain and grow a strong children/youth/family ministry, the council took action, deciding to call an interim synod pastor to serve our children, youth and families until we can complete the call process for a permanent pastor or deacon. Working with the SE Minnesota synod, Zumbro Lutheran hired Pastor Anna Ferro to serve as interim pastor for children, youth and family through summer. To focus on a permanent staff member in this area, the council convened a Children, Youth and Family Call Committee to work in collaboration with the synod to discern the primary needs and characteristics of a person to fulfill this ministry, identify and interview candidates, and recommend a final candidate to the council before a congregational vote to call an individual. Thank you to the members of the committee for this vital work.

The council formed a working group to restart discussing options for the "North Lot" parking areas owned by Zumbro Lutheran, just north and across the street from the church/primary parking lot. The workgroup began with a series of meetings to update information gathered prior to the pandemic. They met with representatives from Mayo Clinic, Destination Medical Center, City of Rochester and a local developer. The council has requested the Finance Team develop a financial effect analysis (FEA) to answer the question, "how will selling or long-term leasing part/all the 'North Lot' properties impact the financial performance of Zumbro Lutheran?" Plans are developing to allow for the congregation to participate in listening sessions to gather your feedback around the possibilities. The workgroup will formulate any recommendations related to the "North Lot" properties and the congregation will ultimately decide whether to sell or lease, all or part of these properties.

The council continued efforts to restart and bolster committees that stopped meeting during the pandemic by adding new members to some committees and restarting a Worship Committee. As 2024 budget discussions began, committee members and the council met to gather input to increase collaboration and communication among Finance, Personnel, Gifts & Memorials, and Mission & Outreach.

In the midst of change and challenge, all of us should continue to be inspired by our members daily acts of living out our mission both inside and outside the walls of our building:

Our journey of faith leads us to build bridges of understanding and peace, to reach out with compassion and to share the hope of Jesus.

The challenges continue in 2024, along with abundant hope. Zumbro Lutheran's culture, values and traditions help this community of faith weather times of change well. Our history shows we are firm in our faith and willing to step up, as we have done this year, to work hard and do what it takes to keep moving forward.

On behalf of the entire council, thank you to the staff and pastors, and to everyone that served on a committee or volunteered in a myriad of activities that offered support to others this year. Special thanks to those of you who support us with your prayers as well.

Thank you for the privilege to serve as Zumbro Lutheran Church's council president. It has been a true honor and blessing.

DIRECTING PASTOR ROB ZAHN

Early in January, I wrote a letter to the congregation lifting up an encounter I had while in the meat aisle at HyVee. Someone approached me and, after establishing I was a pastor at Zumbro, she proceeded to let me know how meaningful she found the Christmas Eve Service at Zumbro. She and her family don't really go to church except at Christmas and Easter and happened to find us for the first time. She said it was the best Christmas Eve she had been to…ever. The conversation drew a small crowd at HyVee.

Just a week or so after that, Pastor Anna told the staff the following story. Here are her words:

While I was out for lunch at Pho Chau, catching up with a couple from my internship congregation who happened to be in town, a gentleman came up to us. I did not recognize him, but he came up to our table and asked me, "Are you a pastor at the church over there?" He pointed towards Zumbro Lutheran Church. I asked, "You mean Zumbro Lutheran?" He replied yes and I replied yes, slightly confused because I have only been here a month. He told me, "I was there for Christmas Eve. I hadn't been there before, but I really enjoyed the Candlelight Service. I just wanted to let you know." I said thank you to him and he walked back to his table. - Pastor Anna

It is one thing for me to list the metrics of our very successful 2023 (which it was!). However, it is quite another to tell a story or two that begins to show what is at the heart of those numbers. And in this case, what is at the heart of one of the better giving years in a decade and a year with healthy New Member Orientation registrations is the impact *you* and this *staff* make here in this community and around the world. Despite the transition and challenges, some of which we knew was coming in 2023, these stories happen because of the culture of the staff and the members of Zumbro.

"Culture eats strategy for breakfast." - Peter Drucker

In short, this means that the culture of our community is far more powerful than any strategic plan we may or may not assemble.

Zumbro's culture is a welcoming culture of grace, mercy, forgiveness, and love *all* in the name of Jesus...and *that* is powerful stuff!

* * *

When it comes to 'what is next' in the coming months and years, I think a bit about what gives energy to a swing, a swing at a playground.

What do you have to do to make a swing work? You must do two opposite things. You must give energy in two directions. You lean *back* and kick *forward*.

Back, and forward...at the same time...and then reverse it by leaning forward then kicking back.

Leaning Back:

We still talk about COVID and transition. I know I do. To be sure, these events and realities are important and impactful to every organization and every person. Let's be honest. Things get messy in transition, for everyone in every organization. They just do. So how do we move beyond the messiness? How do we find our footing again?

Lean back into the things that got us here.

Recently we have reinstated a new Worship Team, which is up and running. We are on the cusp of revitalizing a new Children, Youth, and Family Team. There are likely other teams that need to be re-formed, other practices that need to be returned to. The message?

There is truth that part of our path *forward* is leaning into our past. We are doing that!

Kicking Forward:

This means we need to do new things. Take some risks. Tweak our patterns. This is what I preached about recently. We need to take seriously that the Holy Spirit grants us gifts and changes us for the sake of other human beings. The Spirit grants us the ability to speak new languages and use new skills so others can hear and experience the Gospel.

...and this is *always* uncomfortable.

This could take many forms: new worship styles and times, new ministries, new methods, and practices of the ministries we've engaged in for a long time.

There have been some examples of 'kicking forward' tossed around in various conversations, such as a campaign to reduce the mortgage and engaging in

conversations about the North Lot, just to name a few. The Staff Administration Team has asked if we can consider kicking forward with "more Staff Development and Team Building opportunities, or an additional staff person to assist with all kinds of office needs, or support getting one additional team member certified to check the boiler." The Gifts and Memorials Team hopes to "grow member awareness for ways to make planned gifts to Zumbro Lutheran Church in order to sustain its mission and ministries."

From where I sit, in 2024 we need to 'kick forward' in three major areas:

- Worship: Since that team is almost fully staffed, we need to round out the team with our Worship Band Leader. Then we will have the margin to be continually creative and provide a wide range of worship experiences for all kinds of people who speak different musical languages.
- 2. Children, Youth, and Family: With Pastor Anna on board as our Bridge Pastor and an active Call Committee formed, we are finally ready to fully engage in ministry with the younger families of our congregation, as well as plan ministries that might engage those who are not yet here.
- 3. Financial: Giving has been *incredibly strong!* However, the remodel has doubled our mortgage and the cost of doing business has also increased. We need to aggressively engage in a mix of both increasing our revenue and lowering our expenses (likely focused on debt management), so that the ministries we are called to will be sustainable into God's future.

* * *

As I began this report, I pointed out that Zumbro makes a real impact. God uses this congregation to impact the lives of people in this community and around the world. That is the message that I hope we remember. God is at work through this place. God is at work through this staff. God is at work through...you.

In 2024 and beyond, let us be an example of what it means to follow Jesus. Let us be the ultimate example of grace, mercy, forgiveness, and love - first within our own walls and then out in the world. If we can't be *radical* examples of grace, mercy, forgiveness, and love...then, as that quote reveals, our strategy and vision are meaningless. Let us continue our *culture* of grace, mercy, forgiveness, and love...all in the name of Jesus.

Greetings Zumbro Council and Leadership! I'm thrilled to be writing my first annual report to you all, detailing nearly everything I've learned and experienced here at Zumbro, and in Rochester! Outside of the church I've been slowly integrating and exploring, using my connections with the local music groups to further expand my reach and experiences. I played handbells with the Rochester Symphony for Christmas, played carillon at the Mayo Clinic, became a private pilot, and found several new favorite restaurants and grocery stores!!

Inside Zumbro, I've found a new home, a new way of worshipping, and a new style of worship planning, and I'd love to detail the things that I have experienced and lived during my short tenure here. I asked Pastor Rob Zahn what should go into this report and he thoroughly and systematically reminded me of all the good, cool things that have happened to me these short couple months, and all the great people that I've interacted with that have a hand in making the Music Ministry here what it is.

At Trinity Lutheran, several of the ministry areas that I directly managed myself are, at Zumbro, managed by other people. Janette Davis was my first major contact; as First Impressions Coordinator, she had a hand in helping me to plan and lead worship in our worship space. Part of my ministry concerns the artistic and musical happenings during worship events, and Janette has allowed me to program interesting things and given advice on which things would be interesting and accessible for the congregation to participate in.

Jeremy Stortz has proven an indispensable, invaluable resource with A/V, another part of my ministry that I was directly responsible for at Trinity. With his kindhearted, gentle, and positive attitude towards his own ministry here as

well as his expertise, he's become an integral part of my own music ministry, freeing up my brain to do random musical things instead of trying to find fresh batteries for wireless microphones! I can't tell you how liberating it is to free up that section of time to focus more on making music. I'm also extremely glad to be able to step in and provide knowledge and my own resources to further benefit their ministry. In the future, I wish to be able to explore Jeremys' audio and especially visual interests, and further increasing our digital self. I'd like to provide more high-quality, professional-level video installments, advertisements, and recordings, and make them available to the wider public to push our digital presence into the next level. This will require updating some of our audio and visual equipment offerings, as well as utilizing my own personal experience and equipment stores. I absolutely can't wait to get started on this.

I've been consistently amazed with the work of Julie Knowlton; her artistic skill with visual representation during worship services has regularly elevated our wholly encompassing worship style, and provided great visual inspiration for what I do musically. Again, this was another part of my ministry at Trinity Lutheran that has now been freed to focus on musical things.

Ralph Schornack is another invaluable member of the music team. His excellence with accompanying has freed up my hands to do more conducting and more "hands-on" leadership during choir practices and Sunday services. He is an excellent musician and wonderful colleague, and consistently wows me with his improvisatory skill.

Working with the Zumbro music ensembles has been very inspiring as well. The Zumbro Choir seems to be receptive to my coming, as well as some of my more esoteric musical experiments. The handbell ensemble is strong and eager, and I'm extremely thankful that our new members seem to be sticking it out for the long haul. I've begun the long process of updating our older pieces of equipment and hope to be able to expand our instrument collection to offer more slots for people to play and experience handbells in the future. The Woodwinds have provided excellent musical leadership with their highly skilled instrumentalists, and the Brass Ensemble and Worship band have also been very receptive to my coming.

I'm extremely grateful that the worship band has been receptive to my interim leadership, and hope that soon in the future we will have a specialist who can lead them more effectively than I.

Christmas and Advent went very well; I was very pleased with how everything sounded, and very thankful for all of the volunteers and staff people that made all of that happen.

It is hard to say what the future holds here currently, but I do have several ideas/goals:

- I will be providing regular, full-length organ recitals on the organ, one of Zumbro's most valuable and important musical resources.
- I'd love to be able to do lectures on electro-acoustic music and introduce Zumbro and the Rochester communities to something completely outside of their regular circle of artistic experience.
- I will be strengthening our connections with statewide musical ensembles, including Rochester Area Handbells, Cantus, Luther College, Wartburg College, and others.
- I will be hosting regular hymn festivals, that showcase high-quality traditional liturgy with modern messages and meaningful music.
- I will seek to expand the choir numbers, while growing the current members' skills and knowledge.
- I will update our handbell ensemble's equipment and expand the number of instruments we use to further open more slots to allow more people to join us.
- I will continue to provide high-quality traditional worship liturgies with updated messages, meaningful hymns, and open minded themes, while holding to tradition and utilizing Zumbro's musical centerpieces.

FINANCE TEAM

Post pandemic 2023 was a year of renewed regular meetings, transition to a new accountant, and developing simplified and easy to comprehend accounting reports. As part of this we have taken a hard look at our dedicated funds with an intent to expand on future possibilities for growth and mission. Many of our regular operations have been supported by dedicated funds in the past, and it is our goal to have our actual operational expenses reflected in the 2024 budget. For example, in the past ZWELCA provided coffee, supplies and volunteers to host a Sunday Fellowship hour. Those costs are now transferred to the operating budget increasing our hospitality costs.

Last year, the congregation approved a budget with a \$405,000 deficit planned to be funded by a combination of reserves and cost savings. Thanks to generous contributions, cuts to staff, and assistance from Mission & Outreach and Gifts & Memorials reserves, instead of the budgeted \$300,000 from Capital Campaign reserves we spent \$247,576.

Our mortgage balance at the end of 2023 was \$3,716,425.52. It is a 7-year adjustable loan with a 4.25% interest rate. Moving forward the \$121,473 remainder in Capital Campaign reserves will be divided between 2024 and 2025 for mortgage assistance. Building a sustainable operational budget that includes these costs remains the goal.

Overall, we managed our expenses well, including – completion of the organ restoration, the Giere's retirement events, an extensive hiring process, new coffee machines in the gathering space kitchen, repairs to the Rainbow School Steps, and repairs to the HVAC pipes that shifted due to settling after construction.

2023 highlights:

- Introduced new team members Anne Clarkson, Lori Windhorst and Jason Jadin
- May 20th participation at Rochester Pride at Soldiers Field was successful, even though the weather was hot.
- Sunday, September 20th was the God's Work Our Hands (GWOH) Block Party. GWOH uplifted our primary mission partners at booths providing

printed information, games, quizzes to learn more about each partner and how Zumbro is involved in their support. An outdoor worship was the highlight, with communion served, music enjoyed. Donuts, food, and prizes were part of the day. Worshipers were invited to bring a food product as the focus was how Zumbro was involved in addressing food insecurities. Scouts helped unload the grocery carts and get donations into the church basement. What a collection of food items!

- SEMN Synod Benevolence pledge 2023 was \$80,000. Zumbro had several budget discussions of how to pay the total pledge. August discussion and vote at M&O meeting ended with a unanimous vote to take \$10,000 from our restricted funds. At the November meeting action was taken to direct the remaining M&O general funds of \$3,500 to the Synod pledge.
- Year end gifts focused on Rochester Public School student support projects. Gift cards were purchased for Family Engagement and Area Learning Center Resource Center (ALC), each being allotted \$300 for staff to distribute to meet needs.
- Continuing to explore and respond to what it means to be a downtown church. Keeping the mini pantry filled was a challenge some weeks. A new system of keeping 5-7 bags of food for the week, putting out a bag each day, using food from the Scout food drive and GWOH's food collection. Two breakfast cereal collections, as well as a Thursday night meal, were provided for the Landing.

- We continue to provide food for SE Marion Road guests as well as Francis House, LSS Youth Resource Center, Cronin Home, and occasionally the Landing. We also partnered with the Rochester Fire Fighters.
- Our wonderful paid Coordinator Maddie Eppard continued this year. We added KC Hinz and Christie Atwell as drivers with Josh Dascher taking over truck maintenance duties from Rich Vetter. David Atwell functioned as de facto youth leadership. NICU crew continues to sustain us. We

want to call out Zumbro volunteers Deb Rasmussen, Gary Austin and Debby Jacobsen, as well as community volunteers Mary Beth Magyar and Kyle Hafar who are faithful kitchen folks. Century High School honors program sent us some volunteers (as well as faithful Zumbro volunteer Sam Freimuth) so we continue to make good crosscommunity connections amongst our volunteers.

- Had our very first volunteer appreciation event at Little Thistle so that various folks such as cookie dough mixers and drivers could appreciate each other.
- Excited to continue our partnerships with Boy Scouts via Dan Cozine for food donation drives.
- We received a SE MN Synod Food grant to hire a Somali translator to help us improve trust and connections with our Eastridge guests resulting in a better understanding of how we can best meet their needs.
- We continue to go out every Thursday (with holiday and a few weather exceptions) serving about 200 – 250 burritos and around 150 MCK meals. As of Total expenses were around \$18,696 for all materials and truck maintenance, so that works out to be about \$1.50 per burrito thanks to generous Zumbro and community donations.

In late 2023, the Zumbro Lutheran Church (ZLC) council asked for volunteers to participate in the North Lot workgroup. The purpose of the workgroup is to consider options for the parking areas just north and across the street from

the church. Over the past months, the workgroup has spent time understanding the information gathered by the previous ZLC workgroup as well as the boundaries, city zoning and preliminary market value of the parcels. Members of the team have also met with key representatives from Mayo Clinic, Destination Medical Center, the City of Rochester and a local devloper, to better understand future plans and discuss potential opportunities for collaboration. In addition, the ZLC council has requested the ZLC Finance Team develop a financial effect analysis (FEA) to answer the question, "how will selling or long-term leasing part/all the 'North Lot' properties impact the financial performance of ZLC?"

We look forward to engaging with members of the congregation at listening sessions and gathering your feedback in the very near future. The workgroup will develop recommendations to the ZLC council and ultimately to the congregation for final considerations and decisions.

PERSONNEL TEAM

The ZLC Personnel Committee had a challenging and busy year. The Personnel Committee is charged to support and assist the Directing Pastor to formulate all personnel policies, approve all planned employment actions, review staff performance, and set compensation for our staff. In addition to these formal responsibilities, the Personnel Committee works to support our staff as they respond to the needs of the congregation and share the hope of Jesus.

In 2023 the congregation said goodbye to longtime core staff members Kristy Giere and Bob Giere. The Personnel Committee organized congregational focus groups and formed a search committee to assist the Directing Pastor in recruiting Matt Gender as our new Director of Worship Arts.

There were significant changes in the work assignments of existing staff. We assisted the Directing Pastor in updating job descriptions and moved existing staff to different positions. Sarah Lichty replaced Tracy Schar as our Business Manager. Tracy Schar is now the Facilities Manager. Janette Davis is now our First Impressions Coordinator. We also reviewed changes in our custodial staff and supported the use of contracted custodial services to supplement the excellent work of Jeremy Stortz and Tracy Schar.

Staff performance reviews are conducted by the Directing Pastor. The Personnel Committee was asked by Pastor Rob to conduct private

confidential interviews with each staff member. The results were encouraging. All the staff felt that their working relationship with colleagues was strong and they felt supported by supervisors and the Pastors. They all accepted extra duties during staff transitions and are true servant leaders.

In 2024 the Personnel Committee looks forward to supporting the Directing Pastor and Director of Worship Arts as we recruit a new music leader for contemporary worship.

The Personnel Committee reviewed the performance of our staff and recommended to the church council that a cost-of-living adjustment be awarded to the staff for 2024. Also, based on recommendation from the Finance Committee and with the support of the Directing Pastor, we will work to acquire benchmarks of total compensation to ensure that our staff are "in range" and fairly compensated going forward.

STEWARDSHIP TEAM

Recognizing that we had both significant financial ground to make up (due to the end of COVID-related government grants and the conclusion of the Our Church. Our Future capital campaign) and tremendous opportunity (to inspire people to continue their legacy of strong and generous financial support of Zumbro's mission and ministry), the stewardship team set three goals for 2023: increase stated intents to give; develop materials educating on ways to give; foster a culture of gratitude and grace. We did this by:

- Offering a ZED Talk on Giving Beyond the Offering Plate, with newlycreated flyers reflecting different ways to financially support Zumbro and expanding Zumbro's website to increase visibility and simplicity of online giving.
- Working with Sarah Lichty, in her new role as Business Manager, to develop an improved process for tracking and recording gifts, confirming accuracy in automated giving, and directly and indirectly thanking members as they give.
- Enlisting external stewardship expertise via GSB consulting, with emphasis on connecting with other large churches.
- Conducting a fall stewardship campaign under the theme "Planting Seeds," casting vision of ways Zumbro members might invest in children, youth, and families by calling an ordained CYF pastor; expand our mission by constructing a secure in-house food and supply pantry;

and sustain ministry excellence by supporting the increased mortgage that resulted from the conclusion of the capital campaign. Highlights of the campaign included video and print stories of why Zumbro members support our church; a targeted ask for 2024 intended support; a thorough review of our membership database to ensure we are communicating accurately; and lots and lots of thank-yous.

Focus for 2024: Continue work with stewardship consultant, with particular emphasis on cultivating estate and long-term planning gifts. Expand ways we tell the stories of generosity. Trust that "God gives the growth" (1 Cor 3:7b, our fall theme verse) as we all share what we have – passion, time, money, and love of Jesus.

ZWELCA sponsored a variety of mission and spiritual opportunities in 2023:

- Monthly Action Projects supported local and global agencies through kit and supply donations. Gifts were made possible by donations from Zumbro members and Thrivent grants.
- ZWELCA Circles met for monthly meetings.
- Mission groups served at funerals and also knitted, quilted, and donated quilts, shawls, and blankets. Care packages were assembled and distributed to Zumbro college students and Luther students.

Southeastern Minnesota Synod ELCA 2023 Ministry Report

As another year has drawn to a close, we give thanks for what has been and look forward with anticipation and hope.

In 2023, the ministry of the Southeastern Minnesota Synod continued in earnest. Sixty-two congregations engaged in the call process even as some continue their call process into the new year. We were delighted to welcome 21 new rostered ministers into various settings within the synod.

For the first time in several years, we hosted a visit from a global companion synod. Bishop Atahualpa Hernandez of the Evangelical Lutheran Church of Colombia (IELCO) spent a week visiting our synod's leaders, members, and ministries. It was a joy to spend time with him and learn from IELCO's excellent diaconal ministry among the most vulnerable in Colombia.

Our 2023 Synod Assembly, held in May, welcomed Dr. Susan Brower as the keynote speaker. Dr. Brower helped us understand demographic trends across the state and our communities. In May of 2024, we will use this information as a springboard for the focus of our next Synod Assembly. We will welcome Dr. Matt Bloom to share as we consider how each of us can impact our congregations and communities.

As I consider the ministry of the synod in 2024, I am drawn to the phrase *every congregation connected*. In 2023, congregations took advantage of the connections we have with each other; this was especially evident in the continued increase of collaborations between individual congregations. Throughout the synod, congregations have strengthened ministry through partnering with neighboring congregations.

As we draw on the strength of our internal connections, we have an opportunity to engage afresh with the communities our congregations are already a part of. What opportunities are there to be the church for the community beyond our buildings? What is already happening that we can come alongside? What needs of our neighbors currently need to be met?

One of the gifts of being a congregation of the Southeastern Minnesota Synod is that no congregation must go it alone. We are part of a network with congregations and connections that strengthen us and multiply the impact we have in the communities to which we are called.

Programming Highlights

Summer Camp 2023

- 1. Fifteen young adult leaders, including three international staff from Colombia.
- 2. We served 654 campers onsite representing 134 congregations.
- We provided 8 off-site day camps at congregations.
- 4. We delivered a new confirmation camp curriculum written for and taught to campers from multiple congregations, rather than the traditional confirmation camp taught by campers' pastors. The intention was to allow pastors a reprieve from summer teaching, and to allow campers from smaller congregations or congregations where their pastor was on sabbatical to attend confirmation camp.
- 5. Offered Staff-in-training program to high school students at no cost to them.
- 6. Provided financial assistance to 90% of campers.

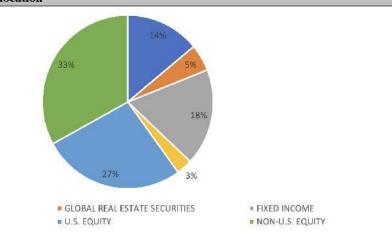

Effective November 1, 2021 the fund's name was changed from "Fund A" to "Ministry Growth Fund".

Annual distribution amount (paid quarterly) for 2022 was \$55.078 per unit. The annual distribution amount for 2023 is \$54.923. Both represent 4.0% of the average market value of the five previous year ends. All purchases, including reinvestments, are made at the previous month end unit value. For example, all March additions and reinvestments were purchased at the February month end unit value. Accounting for the Endowment Fund Pooled Trust is on a market value basis.

The management fee is based on the Ministry Growth Fund's net asset value and is paid monthly to the trustee on the last business day of each month. The management fee is an administrative fee of 60 bps and an expense ratio of approximately 49 bps.
